MGKA-36123, trace: Dr. Karl IHM, born 21 Dec. 1907 at Bitsch. Residence (1946) Munich, Hiltensbergerstr. 32. Occupation; Gynecologist. Held rank of SS Hauptsturmfuehrer in SD, from 1933-1945 (Source: Arrest Report (CI), dated 14 May 1946. ID letter dated 28 May 1948, signed W.K. LIEBEL, states IHM born 21 Dec 1907 in Bitsch, residing Munich, Hiltenspergerstr. 32, connected ZIPPER, Spruchkammer 1 of the internment Camp Moosburg placed Subject in Group IV (Mitlaeuser) on 22 Sept. 1947. Verdict became final on 3 Oct. 1947. In April 48, Subject received letter from Spruchkammer in Moosburg informing him that a new procedure to be started against him because the Workers Council of the 1st Womens Clinic and Midwife School of the University of Munich were not consulted during the original trial. Liebel letter requested MG to stop the new Spruchkammer procedure. Spruchkammer letter dated 7 April 1948, headed Spruchkammer VIII. Stated that new evidence to be heard from the Betriebsrat der 1 Frauenklinik und Hebammenschule der Universitaet Muenchen, Maistr., 11. States IHM was on duty at the Frauenklinik 10 years. Based on new evidence not described, implies that his new classification would not be as good as Mitlaeuser. Letter 28 May 1948 from Donald T SHEA to LIEBEL, states that Spruchkammer III, Munich before which Subject's case pending is now determining on basis new evidence whether another trial to take place, and
