1. Headquarters traces on Inu JAGUSCH:

- a. Source: FX-18, 2 October 1944 - Saint Paris (SB-047)
Subject: Germans registered at Hotel du Louvre, June-Sep 1940.
"Members of SS who stayed at subject hotel - JAGUSCH." co
- b. Source: 200-5-11-1, 10 November 1944
Subject: German Intelligence Service Who's Who.
"JAGUSCH - Hauptsturmfuehrer u. Regierungsrat.
German - had been posted to the staff of BdS Riga but this
was cancelled in April 1943." co
- c. Source: XX-4358, 16 December 1944 - Saint London (BB-055)
Subject: German Organizational Charts.
"This chart shows a Inu JAGUSCH as holding the rank of SS
Hauptsturmfuehrer (Captain), and holding the civil servant
rank of Regierungsrat. He was on the staff of the SS
Commander-in-Chief for the provinces of Lorraine and Saarland.
JAGUSCH was directly responsible to the C-in-C Major General
DUNCKERN and served in a capacity similar to that of Judge
Advocat, whose duties included disciplinary and other court/
legal actions." co
- d. Source: XX-5032, 18 December 1944 - SCI, 12th Army Group,
APO 655
Subject: Interrogation of NILLES, Pierre Nicolas Jean,
ex-Stapo interpreter, Metz.
"JAGUSCH: SS Hauptacharf; ab. 42 yrs. ab. 1.75 (5'9");
chestnut hair ? combed back; square face; pale complexion;
wide shoulders, medium build; judicial officer of the
Befehlshaber; trial of employees by their own court (SS-
and Polizeigericht); r. aux Cours 10. Amt IV." co

2. Comparing the above information with the BDC traces received on Heinrich and Walter JAGUSCH, the conclusion is that Walter JAGUSCH is most probably the SS officer in question. Pertinent details from his BDC trace indicates:

- a. His rank and position was the same as l.c. above.
- b. He was considered for transfer from BdS Metz to BdS Riga.

c. The physical description in l.d. above appears to compare with his BDC photographs.

d. That he is identical with the JAGUSCH of paragraph l.B. of MUNI-6980, 1 August 1963.

3. The information of Alfred JAGUSCH can be discounted. ~~He is not mentioned in MGFA-6484, and EGNA-3823 cannot be located.~~
~~checks out as Subject of paragraph 2. and 3. of MUNI-6980.~~

4. The inu JAGUSCH (Subject of [] can be discounted considering the date of birth and the lack of further identifying data. (This JAGUSCH identical with paragraph l.C. of MUNI-6980.)

He is not mentioned in MGFA-6484, and EGNA-3823 cannot be located.
