1. AEMARSH 15 reported to the undersigned on 28 January 1959 by telephone from Stockholm that he had just received another message from Identity B of Reference. The message was by means of the cipher described in Reference and was the second occasion that Identity B (Reference) had employed it. The message is to the effect, as far as could be understood, that a good friend of subject Identity B's will arrive in Finland within a month to attend an agricultural conference. Identity B urged AEMARSH 15 to contact his friend and has given him AEMARSH 15's name. The implication being that the friend is recruitable. For obvious reasons, his name was not discussed over the telephone. We will obtain it, and whatever background information AEMARSH 15 has during our next meeting with him on 31 January in Hamburg. We will cable this information when it is available.
2. In the event traces reveal no derogatory information we feel it would be advisable to have AEMARSH 15 make the above contact and assess and debrief this individual, particularly with a view to clarifying the status of Identity B of Reference in as great a detail as possible. If the results are favorable this individual should be further assessed by a case officer and, subject to your concurrence, briefed and trained as well as issued an S/W system.
