As a result of the turnover to [] of the operational handling of AEMARSH/15, it is requested that COB Frankfurt furnish [] with a copy of A/15's Personal History Statement, his 201 file number, and a copy of any memorandum of Oral Commitments that may have been made.</p> <p>2. During an operational meeting with A/15 on 4 May he mentioned that during his recent LEFLUTIER visit in Hamburg he had talked with [] about continuing his intermittent relief package shipments to contacts inside Latvia. He states that this had been agreed in principle and that he consequently has ordered a clothing shipment from one of the commercial concerns in [] engaged in this business. Payment will be due about 13 May and A/15 has turned to [] for the funds. Based on A/15's statements and from what [] recalls of his conversation with [] on 26 March, these periodic shipments by A/15 are in support of a FROB developmental operation. [] Station will make the payment to A/15, and it is requested that COB Frankfurt furnish [] with the allotment number to which the amount should be charged and specify the limit and frequency of future identical expenditures.</p> <p style="text-align: center;">[] []</p>
