1. AEMARSH 15 RECEIVED CALL MORNING 11 SEPT FROM

THAT LATTERS BROTHER WILL VISIT HELSINKI 14 THRU 16 SEPT WITH GROUP FORESTRY EXPERTS FROM LATVIA AND USSR.

LEARNED THIS VIA TELEPHONE CALL FROM BROTHER IN LATVIA EVENING 10 SEPT.  PLANS MEET BROTHER IN HELS. NO FURTHER INFO ON BROTHER NOW.

2.  SENDING AEMARSH 15 HELS TO MONITOR AND GUIDE  MEETING WITH BROTHER, MEET PERSONALLY FOR REDSKIN DEBRIEFING AND POSSIBLE RECRUITMENT IF SITUATION WARRANTS.  PLANS ARRIVE  13 SEPT EVENING AND WILL ATTEMPT REACH  BY TELEPHONE FOR FINAL CONCURRENCE AND INSTRUCTIONS.

3. RECOGNIZE PROVOCATION RISK BUT FEEL POTENTIAL OUTWEIGHS THEM FOR FOLLOWING REASONS:

- A.  RELATIONSHIP MAY FACILITATE S/W CHANNEL.
- B. POSSIBLE SOURCE VALUABLE OPERATIONAL INTELLIGENCE.
- C. ODYOKE NOT INVOLVED DIRECTLY AND ANY BLOWBACK WOULD BE ON LATVIAN EMMIGRATION.

4. REQUEST OPERATIONAL AND POSITIVE INTELLIGENCE REQUIRE
