1. AEMARSH 15 REPORTED MORNING 15 SEPT THAT [] AND UNIDENTIFIED FRIEND MET [] IN LATTER'S ROOM PALACE HOTEL HELSINKI PREVIOUS EVENING ABOUT 2130 HOURS. FRIEND EXCUSED SELF AFTER 15 MINUTES. DURING ENSUING TALK [] CONFESSED HE INSTRUCTED CONTACT [] AND PERSUADE HIM RETURN TO HOMETLAND OR AT LEAST DISCONTINUE ANTI-SOVIET PROPAGANDA IN SWEDEN. AEMARSH 15 OPINED RECRUITMENT [] WAS OUT OF THE QUESTION WHEREUPON [] INSTRUCTED HIM NOT TO MAKE DIRECT CONTACT WITH [] BUT CONTINUE ELICIT THRU [] ALL CIRCUMSTANCES OF [] MISSION AND GENERAL SITUATION LATVIA. [] WOULD HAVE SECOND FAREWELL MEETING WITH [] EVENING 15 SEPT.

2. AEMARSH 15 STATES ABSOLUTELY CERTAIN [] WILL NOT BE ENTICED BACK TO HOMETLAND, BUT, [] IS MOMENTARILY DEPRESSED OVER CLEAR FACT THAT HE AND BROTHER NOW DEFINITELY LOST TO EACH OTHER. POUCHING DETAILS.
