1. One of the aspects of the AEMARSH/15 activity which grew fuzzy in the transfer of A/15 from C is that of A/15's periodic aid packages to Latvia. C has so far given funds to A/15 for this purpose on two occasions, 1200 S.Kr. immediately after our first meeting in late July 1959 and 600 S.Kr. in September. These have been sent to the Riga accommodation address which is Identity to EGFA-27264, 22 July 1959.

2. In the apparent absence of a reply to Reference from Frankfurt, C has had to rely largely on A/15's own statement that these packages were agreed to by C and were in support of the C case. C is not particularly concerned that A/15 is taking advantage of this situation, since he has not so far exhibited any of the more common greedy, gouger symptoms. On the other hand both from the standpoint of case officering and of simple administrative control, C should have some clearer idea of the rationale behind these aid packages and whether Frankfurt is still interested in their being sent. We would, therefore, like to have your views or instructions.

3. A/15 has recently requested 800 S.Kr. for a Christmas package which we will supply once more and charge to ODA/SR as with the earlier sums. We would, however, like to have your reply before making further disbursements of this kind to A/15.
