HEADQUARTERS HAS NO INFORMATION UNAVAILABLE TO COS CONCERNING THE ROGAL CASE AND NO CONFIRMING EVIDENCE THAT ROGAL, A KGB AGENT REPORTED BY <u> </u> IS DEFINITELY IDENTICAL WITH WERNER ROGAL, A FORMER CIC AGENT. WE FEEL NEVERTHELESS, THAT THE TWO MAY WELL BE THE SAME PERSON. <u> </u>'S IDENTIFICATION OF ROGAL'S AMERICAN CASE OFFICER AS R. O. MASON AND MI'S RECORDS INDICATING THAT BROOKS O. MASON / <u> </u> WAS THE AGENT HANDLER FOR WERNER ROGAL WOULD APPEAR TO OUTWEIGH THE INDICATIONS REVIEWED IN PARAGRAPHS 4 AND 5 OF REFERENCE A, THAT THE TWO ROGALS ARE NOT IDENTICAL. SINCE THE MATTER CANNOT BE RESOLVED AT THIS TIME, HOWEVER, IT IS SUGGESTED THAT THIS CASE BE TURNED OVER TO CAVATA AS REQUESTED IN REFERENCES D AND E WITH THE COMMENT THAT DESPITE INTENSIVE INVESTIGATION WE ARE UNABLE TO DETERMINE WHETHER WERNER ROGAL IS IDENTICAL WITH THE KGB AGENT OF <u> </u>'S REPORT.</p> <p>2. WE ARE REQUESTING PERMISSION FOR KUBARK DEBRIEFING OF MASON, A MASTER SERGEANT ASSIGNED TO VAIHINGEN /NEAR STUTTGART/ AS OF LATE 1962, REGARDING HIS KNOWLEDGE OF ROGAL AND TO CLARIFY, IF POSSIBLE, ROGAL'S ALLEGED CONNECTION TO COL. 'JANUINS'. SINCE IT IS NOT BELIEVED NECESSARY TO DELAY THE TURNOVER OF THIS CASE TO CAVATA PENDING THE ABOVE PROPOSED INTERVIEW WITH MASON, PLEASE FORWARD TO BONN THE ABOVE INFORMATION ON WERNER ROGAL WHEN PERMISSION TO PASS THIS MATERIAL TO CAVATA IS RECEIVED FROM USAREUR.</p>
