1. ACTION REQUIRED: HQS TRACES ON AHMET KABASHI.

2. ON 12 AUG 96 HABIB AHMET ((KABASHI)) (SUBJECT)
CAME TO THE EMBASSY AND MET WITH STATION OSO. SUBJECT
CLAIMED THAT HIS FATHER, AHMET ((KABASHI)), BORN IN 1913 IN
KOSOVO, WORKED WITH NWBOLTON TO OVERTHROW THE HOXHA REGIME.
SUBJECT CLAIMS THAT IN 1954 THE SUPERIOR MILITARY COURT OF
ALBANIA FOUND HIS FATHER GUILTY OF TREASON AGAINST HIS
COUNTRY. SUBJECT'S FATHER WAS SENTENCED TO DEATH, BUT THE
SENTENCE WAS COMMUTED AND HE SERVED 25 YEARS OF IN PRISON.
UPON COMPLETION OF HIS SENTENCE KABASHI WAS RELEASED AND
RETURNED TO THE VILLAGE OF KABASH WHERE HIS WIFE AND TWO
OLDER CHILDREN LIVED. KABASH IS NOW DECEASED.

3. SUBJECT'S FATHER, AHMET KABASHI, WAS MARRIED TO
GHILE ((AGUSHI)) WHO DIED ON 20 MARCH 1995. SUBJECT'S
FATHER HAD TWO CHILDREN, ABIB AGUSHI ((KABASHI)) AND
SUBJECT. SUBJECT INDICATED THAT HE AND HIS BROTHER ARE
SEEKING COMPENSATION THAT MAY BE DUE TO THEM SINCE THEIR
FATHER WAS IMPRISONED FOR WORKING WITH NWBOLTON. STATION
HAS NO TRACES ON AHMET KABASHI. BEFORE GOING ANY FURTHER
IN THE BGFIEND PROCESS, REQUEST HQS VERIFICATION THAT
SUBJECT'S FATHER WAS AFFILIATED WITH NWBOLTON. AFTER
RECEIVING HQS TRACES, STATION WILL CONDUCT A DETAILED
INTERVIEW WITH SUBJECT, AS WELL AS A DETAILED INVESTIGATION
OF DOCUMENTS PRESENTED BY SUBJECT. APPRECIATE SUPPORT.
