

During 1968, a confidential source abroad furnished information that Yugoslav Government representatives had furnished to the source a list of names captioned, "THE LIST OF YUGOSLAV EMIGRANTS - TERRORISTS RESIDING IN USA."

Included as name number 5 on this list is the following:

"BRAHIMI Djemailja SACIR,
faked name KABASI SACIR, born 1925.
at Kabasa, Vitina.
Address: Jorsey St Buffalo L.I.N.Y."

On April 4, 1968, MARGARET MESMER, Clerk, Naturalization Office, United States District Court Clerk's Office for the Western District of New York, United States Court House, Buffalo, New York, furnished information that on May 2, 1965, a petition for United States citizenship, number 65300, had been filed at Buffalo, New York, and this petition contains the following information:

A notation on the petition reflects that on September 2, 1965, KABASHI was granted United States citizenship certificate number 8806523.

It is noted that on February 3, 1967, SHAGIR KABASHI was interviewed by a Special Agent of the Federal Bureau of Investigation at his residence, Apartment B-4 849 Busti Avenue, Buffalo, New York. He stated that he was born and raised in the Kosovo region of Albania, which is now governed by Yugoslavia and that he came to the United States in 1955 from Greece, to which country he escaped from Yugoslavia because of his complete and undying hatred for the Communist system. He stated that while in Greece he participated in an anti-Communist underground movement aimed at overthrowing the Communist regime in Albania. He stated that in 1959 he became a United States citizen at Buffalo, and that from the time he arrived in the United States and particularly since becoming a citizen he has felt his loyalty belongs completely to the United States and no longer to any Albanian or other type of anti-Communist group. He said if the United States, which is his country now, wants to take any type of action directed against Communism, he will wholeheartedly support any such action, but would not of his own volition take any illegal type of action against the Yugoslavs or anyone else.

KABASHI stated that since 1959 he has been employed at General Motors, Chevrolet Motor Plant River Road Town of Tonawanda, New York.
