 Despite defense allegations that KAYA had not been an active supporter of the militarists while serving in the cabinet, he was found guilty by the International War Crimes Tribunal and sentenced to life imprisonment (12 Nov 48) on five counts: 1 - "the conspiracy to wage war"; 27 - war against China; 29 - war against the U.S.; 31 - war against British Commonwealth of Nations; and 32 - war against the Netherlands. After serving ten years in Sugamo prison he was paroled in September 1955. (pardoned by U.S.)

Reportedly did some traveling in China while associated with North China Development Company from 1939 to 1941.
