2. According to Munich Base files, Prof. Ulrich KAYSER-EICHEBERG (Prof. Juergen KEIL) has been a member of UPHILL since March 1947. In 1958 he was reported to be Chief of a sub-section of West Reports, Foreign Political Reports Group, in UPHILL's Evaluations section. DEGENHARDT told [] in January 1959 that Prof. KEIL might be sent to Washington as Cultural Attaché but we have received no subsequent information that he ever changed jobs. Possibly UPHILL's request for a BDC check is an indication that KEIL is being considered for a transfer or for a promotion.

3. Munich Base files contain no identifiable traces on Heinz SIEPEN.

4. If practical, we would appreciate it if you would add the request to BDC for two copies of their records in such a manner that it will not be necessary for us to send UPHILL such a sliced up sanitized reply.
