Interrogation of Refugees by Zipper Agents		15 Jan. 54	
PERTINENT INFORMATION			
<p>1. In MAS-A-076 we reported the alleged debriefing of two Hungarian refugees, MARKOVITS and KADAR, at 45 Auerpergstrasse, Salzburg, by Zipper Agent, <u>Cyberus/KOLLENTI</u>.</p> <p>2. On 22 December 1950, 480th CIC indigenous employee, Hugo <u>THUX</u>, informed ☐ of our staff that he had been approached by <u>KOLLENTI</u> with the request that he (THUX) forget that <u>KOLLENTI</u> ever admitted the debriefing of KADAR and MARKOVITS. <u>KOLLENTI</u> said that he had been questioned about the debriefing and about his connection with 45 Auerpergstrasse by "his superiors" and said that he had flatly denied all contact.</p> <p>3. Hugo <u>THUX</u> told ☐ that he was reporting the above because he was bitterly disappointed by <u>KOLLENTI</u>'s duplicity, particularly since <u>THUX</u> had had faith in him and done much to help him. As proof that <u>KOLLENTI</u> was in fact involved with KADAR and MARKOVITS, <u>THUX</u> turned over a note addressed to <u>Oliver KADAR</u>, signed with the name "<u>ROSSZU</u>". "<u>ROSSZU</u>" is one of the aliases of <u>OSIKELY</u> (sm), one of <u>KOLLENTI</u>'s regular employees who did the actual debriefing of KADAR and MARKOVITS. One of <u>OSIKELY</u>'s other aliases is <u>Dr. GUTTMAN</u>, in which name the 45 Auerperg Strasse operational area functions. The note asks KADAR for a meeting at 1830 hours at the railroad station in Salzburg. The reply on the reverse side, in KADAR's handwriting, changes the date of the appointment, mentions fifty schillings which he expects to receive from "<u>ROSSZU</u>" and gives the address of one <u>Ilena KOSZU</u>, female friend of KADAR and MARKOVITS. The original note is attached.</p>
