1. SUGGEST FOLLOWING POLICY BE FORMULATED FOR KIBITZ 15 NET, PER REF TWO:

A. IN VIEW OF [ ]'S UNAVAILABILITY WE SHALL IMMEDIATELY  
DETAIL [ ] TO SURVEY NET.

B. [ ] WILL BRIEF DR. GLOBKE IN GENERAL TERMS  
OF NET'S EXISTENCE AND PURPOSE FOR WHICH ORGANIZED AND STATE OUR  
INTENTION IS TO KEEP NET ON A HOLDING BASIS. GLOBKE WILL BE ASKED  
TO CLEAR THIS WITH CHANCELLOR, AND IF AGREEMENT NOT FORTHCOMING  
NET WILL BE DISBANDED. IF NET'S CONTINUANCE AGREED, BFV ALSO WILL  
BE NOTIFIED OF NET'S EXISTENCE.

2. FEEL FOREGOING WILL PROVIDE FOR POLITICALLY SAFE CONTINUATION  
OF KIBITZ OPERATION. NO IMMEDIATE RISK OF FLAP IN OPERATION FORESEEN.  
IF FED GOV DOES NOT AGREE TO NET'S CONTINUANCE, THAT FACT WILL HELP  
PHASE-OUT AND DISPOSAL OF AGENTS.

3. RE PARA 4 REF (THREE). REF TO GENERAL HOW INACCURATE;  
CORRESPONDENCE IN QUESTION PERTAINS TO AN EXCHANGE BETWEEN KIBITZ 15  
AND MAN WHOSE SIGNATURE LOOKED LIKE "DORN", AND CONSTITUTED CRITICISM  
OF RIA MIA OFFICE AND GERMAN MILITARY PLANNING. THIS ESTABLISHED BY  
[ ] AFTER THOROUGH RECHECK OF 15'S FILES SUBSEQUENT TO HIS  
REMARK TO [ ]
