1. VIEW POLICY STATEMENT RE KUBARK STAYBEHIND PROGRAM GERMANY (DIR 28195 PARA 5) AND STATEMENT SAME EFFECT TO FEEL K 15 NET SHOULD BE DISPOSED OF. FEEL ZIPPER SHOULD BE GIVEN OPPORTUNITY ASSESS NET FOR PURPOSE SALVAGING USEABLE PORTION. THIS GOOD OPPORTUNITY CAPITALIZE ON STATEMENT AND ENHANCE ZIPPER GOOD WILL VIS A VIS KUBARK.

2. IF ZIPPER WILLING TAKE NET WITH IDEA UTILIZING ALL OR PART OF IT THIS REPRESENTS AT LEAST PARTIAL REALIZATION KUBARK INVESTMENT AND WOULD LEAVE KUBARK PERSONNEL FREE BUILD UP SINGLETON AND DOUBETON TEAMS. DISSOLUTION REPRESENTS COMPLETE LOSS AS WELL AS DISPOSAL PROBLEM. ONLY OTHER ALTERNATIVE IS OVERHAUL NET AND CONTINUE TO RUN WITH FULL KNOWLEDGE ZIPPER AND GLOBKE. LATTER NOT PARTICULARLY DESIREABLE HOWEVER VIEW LACK KUBARK PERSONNEL AND DUBIOUS AMOUNT CONTROL KUDARK CAN EXERT ON K 15 AND SUBAGENTS.

3. FOR THESE REASONS BELIEVE CASE SHOULD BE PRESENTED UTILITY WITH STATEMENT WE REALIZE DEFICIENCIES OF NET BUT IF ZIPPER WANTS IT IN ENTIRETY OR IN PART WE WILLING TURN OVER. IF UTILITY ACCEPTS NET HE WILL HAVE CONSIDERED SECURITY AND LEGALIZATION ANGLES AND WILL HAVE DECIDED THAT RISK ACCEPTABLE. WILL PRESUMABLY ALSO HAVE CLEARED ^R WITH BLANK OFFICE AND/OR GLOBKE.

5. IN CASE YOU CONCERNED POSSIBLE DILUTION PRESENT ZIPPER STAY-
BEHIND ASSETS BY K 15 AGENT PERSONNEL, FEEL K 15 AGENTS NEED NOT
BE INTEGRATED EXISTING OR PROJECTED STORCH TEAMS.

6. IF WE TAKE INITIATIVE IN PRESENTING NET TO ZIPPER AND/OR
ADVISE GLOBKE OR BLANK WE ELIMINATE POSSIBILITY UNILATERAL PEDDLING
EFFORT ON PART K 15.

7. WHILE WE UNDERSTAND POBS RELUCTANCE, CONSIDER PARAS 1 B AND
E ONLY REALLY VALID OBJECTIONS AND WE FEEL UTILITY'S OPINIONS THESE
POINTS CONSIDERABLE IMPORTANCE. WE WISH EMPHASIZE THAT TURNING NET
OVER TO ZIPPER IS MOST DESIREABLE COURSE OF ACTION FOR SEVERAL
