2. SUBJ RABID NATIONALIST DIFFICULT TO CONTROL BUT SINCERE IN DESIRE COMBAT COMMUNISM. ORIGINAL RECRUITMENT RESULT LETTER SUBJ WROTE MCCLOY OFFERING SERVICES. SUBJ RECONTACTED KUBARK FALL 1953 WITH NEW PROPOSAL REDCAP FIELD FOR WHICH WE THANKED HIM AND SAID GOODBYE.
3. ASSUME LETTER REF WRITTEN AS PRIVATE INDIVIDUAL NOT OFFICIAL. THIS INTERESTING AS DA REPORT R-4-56 DATED 26 JAN 56 LISTED INDIVIDUAL SAME NAME AND PROBABLY IDEN WITH SUBJ AS HAVING RECEIVED COMMISSION LT COL WEST GERMAN ARMY.
4. ABOVE FYI. IF FRAN CONCURS REQUEST YOU ADVISE G-2 SUBJ WAS PA KUBARK STAYBEHIND TERMINATED DUE FAILURE ADHERE OUR SECURITY STANDARDS. REQUEST G-2 REFRAIN CONTACT AT LEAST FOR PRESENT AND ALLOW FRAN HQ SEE LETTER FRICR ANY ACTION.
