2. [ ] READ LETTER WHICH CONSISTED MAINLY OF PITCH THAT USAREUR SHOULD DEVELOP GW PROGRAM AND AS OLD HAND WOULD BE GLAD TO HELP FOR GOOD OF THE CAUSE. CITED WW II USE BY SOVS, LESSONS LEARNED, HIS WORK WITH ANOTHER AMERICAN AGENCY AND INDICATED USAREUR BEST BET BECAUSE MATTER TOO HOT POLITICALLY FOR FEDREP TO HANDLE, OR REGARDED WITH INDIFFERENCE. SUBJ SIGNED LETTER AS RETIRED OFFICER.

3. ON BASIS ABOVE CONCURRED IN RECOMMENDATION PARA 1 ABOVE AND MATTER CONSIDERED CLOSED.
