- In accordance with paragraph 2, Reference B above, AECAPPELIN has been persuaded that he and his wife should remain in Germany until his KUBARK employment in that country is completed. He was assured, however, that when that time comes, both he and his wife would meet no undue difficulty or delay in emigrating to the United States. Both expressed satisfaction with this arrangement, and it is felt that the matter should remain at this agreeable stage until AECAPPELIN's usefulness here ends. *Amen.*
- Mrs. AECAPPELIN, at times, shows signs of presenting a morale problem. This is evident from the sporadic requests AECAPPELIN makes, requests generally associated with the placating of his wife. It is to be noted that Mrs. AECAPPELIN is well aware of her husband's intelligence activities and is often party to them, as evident in her role in the BAUMBACH affair and in her knowledgeability regarding AEGANDIOT and AEGAVATINA 12. The psychologist who interviewed Mr. and Mrs. AECAPPELIN last fall in connection with immigration requirements, at which interview the undersigned interpreted, remarked afterward that a problem in sexual compatibility seems to trouble the couple.
- On 15 March 1954, AECAPPELIN made a new request which again stems primarily from his wife. He asked that \$500.00 from his escrow account be sent to Identity A (Mrs. AECAPPELIN's father). This sum will represent AECAPPELIN's contribution in a family effort to bring Identity B (Mrs. AECAPPELIN's sister and family) from Argentina, whither they had emigrated in 1949, to Canada for permanent residence there. Unemployment, the hot climate, and a desire to be near relatives are the reasons given for Identity B's desire to go to Canada. Identity B does not have the money needed for their migration, the total cost of \$1500.00 by family agreement is to be split evenly among Identity A, Identity C (Mrs. AECAPPELIN's brother), and AECAPPELIN. AECAPPELIN stated that on 8 March 1954, Canadian authorities had approved Identity A's request to bring Identity B to Canada as immigrants. Lack of funds alone now prevents their departure.
- Approval of the transfer of \$500.00 from AECAPPELIN's escrow account to Identity A
