- RE COVER: AECAPELIN ACCEPTED AS ADVANCED THEOLOGY STUDENT SAINT SERGIUS INSTITUTE DE THEOLOGIE ORTHODOX DE PARIS, XIX, 93 RUE DE CRIMEE.
- AECAPELIN WROTE HIS SUPERIOR ATHENAGORAS II IN LONDON FOR PERMISSION LEAVE MUNICH WHICH ONLY FORMALITY AND WILL BE GRANTED. HE WILL SEND CERTIFICATE WITH STUDENT APPLICATION TO SAINT SERGIUS WHICH THEN WILL OBTAIN PARI RESIDENCE PERMIT FOR HIM.
- AECAPELIN CONFIRMED WITH FRENCH CONSULATE MUNI HE MUST SUBMIT FINANCIAL RESPONSIBILITY STATEMENT ORDER OBTAIN STUDENT VISA. CASH CAN BE DEPOSITED BANK FRANCE OR FEDREP. ORDER EXPEDITE SUGGEST DEPOSIT EQUIVALENT \$1,800 IN TRUE NAME IN SWISS BANK. AECAPELIN THEN CAN PRESENT DRAFT ON SWISS BANK TO GERMAN BANK AND DEPOSIT.
