MEMORANDUM FOR THE RECORD

SUBJECT: ~~AKDOOMA-1~~ []

1. Subject, who is Mikhail KORZAN, is better known as ABCAPELIN-1, an Ukrainian emigre and ordained Orthodox priest who served with German Military Intelligence (Abwehr) during World War II.

2. Some time ago, Subject's case was discussed with [] of SR/2, which became interested in Subject only recently because of his move from Munich to Paris. He pointed out that Subject, who has long been the Munich Base's oldest agent, has been working for us for a very long time. The sheer length of his service makes the origin rather cloudy. As best as [] could determine, Subject was introduced to OSS in Salzburg, Austria, at war World War II by "Uncle Tom" (not further identified) to "Novak" -- Arati of OSS. Subject's case officers are known to have include [], [], and [].

3. Subject's first wife is in the United States, her entry having been assisted by this Agency. Subject's second wife is in Canada, to which CIA also facilitated entry. Subject himself apparently has been promised entry to the United States under PL 110.

4. From at least 1950 Subject has worked simultaneously both for our Munich Base and for UPSWING, which fact was known throughout by both Agencies. When renewing the AKBATH Project, CI Staff concurred in the transfer of Subject to Paris for exploitation as an unilateral asset with the clear understanding that Subject would have terminated his UPSWING prior to the move. The SR memorandum indicated that this had been done. Subsequently, it developed, however, that the Munich case officer never did insist on the termination of the UPSWING contact and on the contrary that UPSWING was to continue its active contact with Subject even in Paris.

5. [] of SR stated that the UPSWING desk at Headquarters had given some indication that the UPSWING desk considers that Subject's UPSWING contacts, namely, SCHMALSCHLAGER of the field office and Oscar REILE in UPSWING Headquarters are Soviet intelligence suspects and either [] or [] for both believe it possible that the maintenance

of UFGMW contact with Subject might be actually for the benefit of Soviet Intelligence. The reasons for these suspicions are not known to undersigned.
