It would appear that he has no interest at all in coming to PBPRIME for any reason. He signed both the receipts for the 60,350.25 DM which he received and the quit claim without question. He did, however, make two points in reference to money which he believes due him in excess of the sum he received.</u></p> <p>a. Sometime ago AEDOGMA asked for the <u>amount in his holding account of that time. A figure was given him at that time which he carefully noted. Using that figure, AEDOGMA reckoned that he should have around \$15,000 in his account. We told him, after checking with Headquarters twice, we were fairly certain that the sum was correct as given him. However, we would check one more time and make certain that we had received the full amount of his holding account. We, therefore, request that one more check be made to ascertain that the amount as given in previous traffic to be the correct sum of AEDOGMA's holding account up to 31 December 1961 is in fact the correct amount.</u></p> <p>b. During the time between Headquarters advice to terminate Subject and the actual termination, Subject had called MOG to find out what he should do with his Paris apartment. He was instructed to keep it for the time being. This means that Subject will now have to travel to Paris to pick up his gear stowed there and liquidate the apartment. Unfortunately this figure, about 500.00 DM was not included in his pre-termination discussions with [redacted]. It is our opinion that Subject is entitled to this money [redacted] approval of this expenditure has been received.</p> <p>2. Subject had very little to say about the quit claim. He asked if we would consider odd jobs for such persons as Mikola LEBED as work for an AIS component. We replied immediately that such odd jobs would not fall under the prohibitions of the quit claim in regard to working for any other AIS element.</p> <p>3. <u>We told Subject that, while his status as a paid agent has been terminated, we would not object to hearing from him if he should turn up something really hot or fall into some kind of grave personal emergency.</u> On the other hand we hinted fairly broadly that the usual Ukrainian emigre gossip was no longer of any interest to us. Subject immediately agreed with this position rephrasing our statement along lines that the business contact is broken but the normal human communication is still there.</p>

I, Michael KORZAN, acknowledge herewith and admit understanding that the 60,350.25 DM which I have received from the U.S. Government on 18 October 1961 is a final payment of my salary from the U.S. Government and that I have no further demands or requests whatsoever on the U.S. Government. I received this money for:

- (1) 54,443.75 DM as termination bonus
- (2) 5,906.50 DM for salary from June through December and other expenses as agreed with representatives of the U.S. Government

Although I have received my whole salary, I pledge that I will not take up cooperation with any other American Intelligence service. If I am approached by any other American Intelligence service, I will refuse to cooperate and report this approach to the Munich telephone number known to me.

If I should have interest in settling in the USA, it is clear to me that my service for the U.S. Government does not constitute any firm promise of unusual aid in this resettlement. If I should travel to the USA I declare myself prepared to pay the transportation cost and ready to be investigated by the appropriate American officials.

I also pledge to be silent about my cooperation with the American Intelligence service to all persons. In addition, I will not publish anything about this cooperation or let anything be published.

Ich, Michael KORZAN, erkenne hiermit an und bin mir vollständig in Klaren darüber, dass die 60,350.25 DM die ich am 18.X.61 von der U.S. Regierung erhalten habe, als eine endgültige Zahlung meines Gehaltes von der U.S. Regierung gilt und, dass ich keinerlei Forderungen oder Ansprüche an die U.S. Regierung habe. Die Summe (60,350.25 DM) erhalte ich als,

- (1) 54,443.75 DM Schlussprämie,
- (2) 5,906.50 DM Gehalt fuer die Monate Juni durch Dezember und fuer Unkosten wie mit Vertreter der U.S. Regierung vereinbart.

Obwohl ich mein ganze Gehalt erhalten habe, verpflichte ich mich mit keinem anderen amerikanischen Nachrichtendienst eine Mitarbeit anzufangen. Sollte ich von einem anderen amerikanischen Nachrichtendienst zur Mitarbeit aufgefordert werde, so werde ich diese Aufforderung sofort ablehnen und die Annäherung sofort an die mir bekannten Münchener Telephonnummer melden.

Sollte ich dafuer Interesse haben, nach den Vereinigten Staaten zu übersiedeln, ist es mir klar, meine Mitarbeit mit der U.S. Regierung bildet auf keine Weise ein festes Versprechen der U.S. Regierung bei dieser Übersiedlung ausserordentliche Beihilfe zu leisten. Sollte ich nach den U.S.A. reisen, bezahle ich die Reisekosten und erkläre mich bereit von den zuständigen amerikanischen Behörden wieder geprüft zu werden.

Ich verpflichte mich auch hiermit über meine Mitarbeit mit dem amerikanischen Geheimdienst allen gegenüber zu schweigen. Ferner werde ich nichts über diese Mitarbeit veröffentlichen oder veröffentlichen lassen.
