1. INTERVIEWED MICHAEL KORZAN IN MUNICH
 26 APRIL ON REF MATTER. PRESENT DURING INTERVIEW WAS BND OFFICER
 ALIAS WERNBERG WHO SELECTED BY BND FOR THIS TASK BECAUSE HE
 PREVIOUS ACQUAINTANCE OF AND ALSO IS SUPERVISOR OF KORZAN'S
 USUAL BND BCASE OFFICER. KORZAN WAS VERY COOPERATIVE AND OFFERED
 ASSIST IN FUTURE IN ANY MANNER DESIRED.

2. OUTCOME OF INTERVIEW IS THAT AFTER INITIAL UNCERTAINTY
 KORZAN IDENTIFIED PHOTOS SUPPLIED BY HEADQUARTERS AS OF VIKTOR
 SABAL. KORZAN THEN REPORTED THAT HE HAD MET SABAL A TOTAL OF
 ABOUT THREE TIMES, THE FIRST BEING IN MUNICH "ABOUT TEN YEARS
 AGO" AFTER SABAL RETURNED HERE FROM THE U.S., AND THE MOST RECENT
 ALSO IN MUNICH IN DECEMBER 1973 AT THE BEDSIDE IN A MUNICH CLINIC
 OF A MUTUAL FRIEND, BORIS LEVITSKI . EVERYTHING KORZAN
 HEARD AND REPORTED ABOUT SABAL'S PARTISAN ACTIVITY DURING WORLD
 WAR TWO CAME FROM BORIS LEVITSKI: KORZAN HAD NO DIRECT KNOWLEDGE OF

SABAL DURING THE WAR. NEVERTHELESS FROM ACCOUNTS OF THEIR WARTIME ACTIVITIES BY LEVITSKI; FROM INDEPENDANT PERSONAL KNOWLEDGE OF SABAL'S FIRST WIFE, WHO WAS EXECUTED AT END OF WAR BY ANTI-COMMUNIST ORGANIZATION, AND FROM GENERAL KNOWLEDGE OF PARTISAN ACTIVITIES DURING WAR KORZAN HAS NO DOUBT THAT SABAL WAS IN FACT IN PARTISAN UNDERGROUND.

3. LEVITSKI SERVED IN PARTISAN UNIT NEAR LVOV CIRCA 1940-1943. HE IS NOW PREPARING (WITH SOME ASSISTANCE FROM SABAL) TO WRITE BOOK ABOUT HIS PARTISAN EXPERIENCES. LEVITSKI IS WELL-KNOWN EXTREME LEFTIST (TROTSKYITE) WRITER AND EMIGRE LEADER WHO HAS ALSO WRITTEN BOOK ABOUT KGB. HOWEVER AT SOME TIME IN PAST HE WAS ARRESTED IN WEST BERLIN ON SUSPICION OF ESPIONAGE FOR SOVIETS. KORZAN SAYS HE HAS NO CURRENT TIES WITH LEVITSKI AND IS NOT TRUSTED BY HIM. KORZAN DOUBTS THAT LEVITSKI WOULD BE WILLING TO SUPPLY ANY INFORMATION TO GERMAN OR AMERICAN AUTHORITIES ABOUT SABAL.
