Dear Mr. Mycroft:

The United States Government, as represented by the undersigned Contracting Officer, hereby contracts with you for the purchase of information and services of a confidential nature under the following terms and conditions:

1. Compensation. In consideration for the purchase of such information and services you will be paid an amount calculated at the rate of \$4,200.00 per annum. Payments will be made as directed by you in writing in a letter acceptable to the government. No taxes will be withheld from this amount and it will be your responsibility to report such income under existing U.S. Federal income tax laws and regulations.

2. Bonus. Upon the satisfactory termination of this agreement without renewal as specified in paragraph 12. hereof, you may receive as a bonus a sum not to exceed \$2,000.00, the exact amount of which will be determined by the government in its sole discretion. In the event that this agreement is renewed for one or more periods of one year each as specified in paragraph 12. hereof, you may receive as a bonus to be paid upon the satisfactory completion of each such period a sum not to exceed \$1,000.00, the exact amount of which will be determined by the government in its sole discretion.

3. Allowances. In the event of duty overseas, you will be provided quarters or paid a quarters allowance pursuant to applicable regulations upon your arrival at your overseas post. There will be no accounting required for payments made under this paragraph.

4. Travel. In the event of duty overseas, you will be advanced or reimbursed funds for your travel and transportation to and from your permanent post of duty overseas and for authorized travel within your operational area. Pursuant to applicable government regulations, you will be entitled to per diem in lieu of subsistence during such travel and during the period you receive training in or about Washington, D.C. All travel and transportation under this paragraph must be properly authorized and expenses incurred hereunder are subject to payment and accounting in substantial compliance with applicable government regulations. You will also be entitled to reimbursement at the rate of seven cents per mile for necessary and authorized official use of your private automobile.

5. Operational Expenses. You will be advanced or reimbursed funds for necessary operational expenses including, but not limited to, entertainment and purchase of information as specifically approved by the government. Such funds will be subject to accounting in substantial compliance with applicable government regulations.

SECURITY INFORMATION

6. Benefits. a. In the event of your death or if you receive an injury or disability while engaged in the performance of your duties under this contract, you or your estate, as the case may be, will be entitled to disability benefits, medical, surgical and hospital services or supplies and transportation in such amounts as the government in its sole discretion shall deem proper.

b. You will be entitled to claim reimbursement for loss of property in accordance with applicable government regulations.

c. Your compensation as set forth pursuant to this contract and your continued right to receive the same will be covered by the terms of the Missing Persons Act of 1942, as amended.

7. Cover. It is possible that you will undertake a cover employment in the course of the performance of your duties under this agreement. It is expressly understood and agreed that any and all documents which you may execute in the course of such cover employment are subordinate to this agreement, and any contradiction in terms which may in any way modify, extend or restrict your rights or obligations hereunder shall be resolved by this agreement which shall always be dominant.

8. Execution of Documents. If, in the performance of your duties under this agreement, you assume the custody of government funds or take title to property of any nature whatsoever and wherever situate, which property has in fact been purchased with monies of the government, you hereby recognize and acknowledge the existence of a trust relationship, either express or constructive, and you agree to execute whatever documents may be required by the government to evidence this relationship.

9. Offset. If you should receive any sums required under the terms of this contract from your cover facility, such sums will be used to offset amounts due and payable by the government. Sums thus received through your cover facility are acknowledged and agreed to be payment by the government to you within the meaning of this contract.

10. Secrecy. You will be required to keep forever secret this contract and all information which you may obtain by reason hereof (unless released in writing by the government from such obligation), with full knowledge that violation of such secrecy may subject you to criminal prosecution under the espionage laws dated 25 June 1948, as amended, and other applicable laws and regulations.

11. Instructions. Instructions received by you from the government or its representatives, in briefing or training are a part of this contract and are incorporated herein to the extent that such instructions are not inconsistent with the terms hereof.

12. Term. a. This agreement is effective as of _____ and shall continue thereafter for a period of two years unless sooner terminated upon thirty days' actual notice to you from the government. Subject to the availability of appropriations, this agreement may be renewed for successive periods of one year each upon notice to you from the government. In the event of voluntary termination on your part or termination for cause by the government prior to the expiration of this agreement or any renewal thereof, you will not be entitled to return travel expenses to the United States.

b. Termination of this agreement will not release you from the obligations of any security oath you may be required to take.
