1. FOLLOWING VIEN VIEWS KOVACS OP:

A. KOVACS INFO WILL ONLY SUPPLEMENT THAT FROM [] WILL NOT SHED MUCH MORE LIGHT AVH OPS EXCEPT 8/4 BRUS.
