1. There are forwarded herewith our copies of intercepts of the Subject's mail during the period 23 Jan. to 3 March 1950. Lack of translation facilities prevents full translation here; free translation of some excerpts only follows in Para. 5.

2. Coverage was requested on the foreign mail and telegrams for Subject, Hermann BAUN and TETEX GmbH, with the notation that resumes would be sufficient, unless the substance was suspicious, either in content or appearance, i.e., possible code or double meaning text. Tests for S/W were not requested. Coverage was discontinued because the yield, at the time, was not considered worthwhile.

3. Since that time, Subject has come to our closer attention and now appears to be of greater interest. On the basis of these intercepts and the present view which you hold of subject, it is requested that you advise whether you consider resumption of such coverage desirable at this time. If so, where will precise translation be accomplished?

4. Traces on the various correspondents, addressees and individuals and organizations mentioned in these intercepts are requested from you, as well as from COS, EIS, and CIS.

Mr. WIND has already gone to the EUROPARAT office in Duesseldorf, at the French office, where they wanted to

seal the deal with him, but he first got in touch with the British. The English also showed interest and wanted Mr. WIND to come live in the English Zone right away. So far nothing has happened definitely. In the meantime, Mr. WIND has made contact with the Iranians and has learned French and English.

He no longer lives at Golzheimer Heide 1, but at Dusseldorf-Unterrath, Irenenstr. 76a.
