MEMORANDUM FOR: Chief, SR Support Staff

SUBJECT : Full Per Diem Claims for Alek Kurgvel

1. The cost figures submitted by subject fail to support his claim for full per diem. Full per diem is \$19.00 per day, the reduced per diem after 60 days is \$12.66. The Baht is worth approx. .05 each (20.65/\$). TDY period in Bangkok was 11 Feb. to 11 June.
