1. SUBJECT OF REFERENCE A IS STILL UNDER SUSPICION BUT CATIDE HAS APPARENTLY NOT BEEN ABLE TO OBTAIN ANY EVIDENCE OF CURRENT EASTERN INTELLIGENCE CONNECTIONS. THEY THEREFORE WISH TO ASSEMBLE AS MUCH INFORMATION AS POSSIBLE CONCERNING HIS WARTIME CAREER IN THE HOPE THAT THERE WILL BE SUFFICIENT GROUNDS FOR FIRING HIM. SUBJECTS OF REFERENCE B WERE HIS COMMANDING OFFICERS DURING WORLD WAR TWO AND THEIR BDC FILES MAY SHED ADDITIONAL LIGHT ON SUBJECT'S ACTIVITIES.

2. ALIAS FLEMING STATED THAT [Deryabin] FURNISHED SOME DEROGATORY INFORMATION CONCERNING A MEMBER OF A WORLD WAR TWO UNDERTAKING /CODE NAME 'ZEPPELIN', WHICH PROVIDED GERMAN SUPPORT TO CAUCASIAN ANTI-COMMUNISTS. SUBJECT BELONGED TO ZEPPELIN AND IS POSSIBLY THE PERSON ABOUT WHOM [Deryabin] REPORTED.

3. WE HAVE NOT BEEN ABLE TO LOCATE THE [Deryabin] MATERIAL IN QUESTION AND WOULD APPRECIATE HEADQUARTERS' REPEATING IT OR IDENTIFYING THE SOURCE DOCUMENT.
