1. Reference A advised that UPSWING was briefing a case officer on 17 May 1957 for contact with Subject. This information appears to be at odds with what we have received from Subject. Her letter of 10 May (Ref B), and a subsequent letter dated 14 May 1957, received here includes reference to the fact that she had been contacted by someone (presumably by UPSWING) prior to 10 May 1957. We would appreciate clarification, for obvious reasons.

In this connection, your attention is invited to the material forwarded via Reference C, dated 9 May 1957. It is believed that the use of this material will save considerable time.
