1. Reference No. 1, forwarded certain documents and correspondence belonging to Subject, which she turned over to the BFV (see Ref. No. 2, page 13, paragraph 1, ii) at Marienfelde on 13 December 1956. Among other items, copies of which are included herewith, is a partial envelope post-marked Hartford, Connecticut, 19 November 1956, an item we requested BONN to recover from the BFV earlier this year.


2. The partial envelope was of interest to us at the time because we were desirous of determining, if possible, its authenticity through technical examination by MKTOPAZ. In view of the transfer of the operation to PCB, this has not been done.

3. Reference No. 1 also included a request from the BFV for the return of the enclosures and adds that the BFV desires a summary or copy of our interrogation of Subject, whose Berlin BFV processing was prematurely terminated at our request for access.

4. We believe that we should honor the BFV request and therefore are desirous of returning the original of the enclosure to this dispatch,





and a copy of the attachment to Ref. No. 2. This is considered necessary in order to maintain a good relationship locally with the BFV. It should be noted that we passed a similar report to the British on Subject's background, at their request.

5. In view of the ever-increasing flap potential inherent in Subject's case, we believe it advisable to go on record with the local BFV to the effect that we are no longer in operational contact with her, interest having been transferred to another Western Agency, identity not specified at Subject's request.
