CAVATA Request for Information - Hildegard LACHERT

1. Returned herewith per paragraph 2 of reference A are the personal papers of LACHERT.

2. Transfer of the LACHERT operation from BOB to POB was effected late in May 1957. POB has requested that the enclosure hereto be passed to them for use of UPSWING. They add also that if CAVATA feels strongly about retaining possession of these attachments, they do not think it advisable to press for them.


3. It is recommended, and POB concurs, that CAVATA be advised that the LACHERT matter has been passed to another Western Service, being of course non-specific. This course of action is deemed advisable in view of the flap potential involved in handling LACHERT.
