1. REQUEST TRACES EDWARD MALINSKI, (RESIDENCE: NOWA WIES

MATA, P-TA. LENIN BRESKI, POLAND) AND ERIKA JABLONSKA (RESIDENCE: DNEVWENOW ST., WROCLAW, UL. KOSCICHNE 19 II P) WHO ARE ALLEGEDLY ACTIVE IN POLAND ON BEHALF U.S. INTELLIGENCE. ALLEGATION IS FROM HILDEGARD LAECHERT [] DPOB 19 MARCH 20 BERLIN, PRESENTLY IN HEIDELBERG STATE PRISON AWAITING TRIAL FOR NAZI WAR CRIMES AND PROBABLY SUFFERING FROM MENTAL DISORDER RESULTING FROM ADVANCED VENERAL DISEASE. ALLEGATION WAS PART OF ACCOUNT OF SUBJ'S CONTACT WITH U.S. INTELLIGENCE WHICH WAS PRESENTED ON HER BEHALF TO 66TH HEIDELBERG FIELD OFFICE ON 18 JULY 74 BY ONE HEINZ SCHROETER, DOB 19 JUNE 43, STUDENT OF THEOLOGY AT UNIVERSITY OF HEIDELBERG, WHO AS PART OF HIS CURRICULUM VISITS INDIVIDUALS INCARCERATED IN HEIDELBERG STATE PRISON. LAECHERT TOLD SCHROETER THAT SHE IS BITTER ABOUT HER CURRENT CIRCUMSTANCES AND THAT IF USI DOES NOT INTERCEDE ON HER BEHALF, AS MEANS OF SELF PRESERVATION SHE WILL BE FORCED TO TELL ENTIRE STORY HER BACKGROUND, INCLUDING NAMING USI

OPERATIVES IN POLAND. SHE STATED HER AFFILIATION WITH USI MAY BE VERIFIED BY RECORDS IN WASHINGTON, DC, AND THAT HER COVER NAME WAS "FLORIAN".

2. ACCORDING TO 66TH, CENTREG TRACES ON LAECHERT INDICATE SHE WAS DEBRIEFED BERLIN, PROBABLY BY CIA, IN DECEMBER 57 WHEN SHE MOVED WEST BERLIN FOLLOWING HER RELEASE FROM POLISH PRISON WHERE SHE HAD BEEN INCARCERATED SINCE CA 47 FOR NAZI WAR CRIMES.

3. MUNICH BASE HAS NUMEROUS CARDED REFS TO HILDEGARD LUISE LAECHERT, DPOB 19 MARCH 20 BERLIN [], TO HER SON DIETER HANS JURGEN LAECHERT, DPOB 23 AUGUST 39 BERLIN, AND HER DAUGHTER KAREN REGINA GISELA LAECHERT, DPOB 3 APRIL 41 BERLIN. PRESUME MATERIAL AVAILABLE IN []
