PERTINENT INFORMATION	
14. Kriminalkommissar Kurt LAHR, in charge of the II/G Section, Rheinland-Pfalz LfV, came to the attention of LfV Chief Bernhard KAESBERGER in December 1955 in connection with a drinking bout in which LAHR had participated in October 1955. Allegedly, LAHR became intoxicated while carousing and drinking with two other men and stated that "he saw nothing wrong in the operation of the Concentration Camps" under Hitler. When he was sober again, LAHR anxiously begged one of his drinking companions not to mention to anybody his remark about the concentration camps. KAESBERGER appreciates the capable work LAHR has been performing in the field of counter espionage, but is concerned about an employee who will speak his mind in public under the influence of liquor. Prior to the incident, KAESBERGER considered LAHR an officer whose morals were beyond reproach and who could be recommended for promotion.
