UPHILL requests traces on Kurt LAHR [] In view of the CADAISY involvement and FOB's previous association with LAHR, we suggest that FOB advise what may be passed to UPHILL.</p> <p>2. LAHR applied for a job with UPHILL in June 1962 and UPHILL has decided not to hire him. Their current interest stems from similarities between LAHR's World War II career and those of UJDRUM and UJDROWSY and his sudden interest in working for UPHILL. UPHILL apparently is not aware of the background reported in reference concerning LAHR's difficulties within the LfV Rheinland-Pfalz. We will be interested in anything [] reports on LAHR's unsuccessful attempt to join UPHILL.</p> <p>3.
