Subject: LCIMPROVE - Kyril CORNELL, Soviet Spy
(Results of interrogation)

Page 3. CORNELL learned from a letter written to him by an old friend in Munich, Viktor LARIONOV, that OKOLOVICH escaped from the USSR after the war and has since been working in Germany for the national labor union (NTS) which is an anti-Soviet organization. LARIONOV further reported that MUZANEX was about 60 years old and had formerly worked under someone named Viktor OREKHOFF /OREKHOV/ in the anti-Soviet organization RNO (Russian National Union) in Brussels, but that MUZANEX went over to NTS where he was working solely to make a living without any particular political persuasion...

Before CORNELL left on summer vacation in 1959 to Germany, Belgium, France, his Soviet case officer gave him the assignment to gather information on emigré organizations, NTS, SBORR, TSOPE, RNO...What countries' intelligence services were cooperating with these organizations. Answers...were obtained by CORNELL from Viktor LARIONOFF who lives in Munich and from the Chief of RNO, Vasily OREKHOFF, who lives in Belgium and whom CORNELL also got to know...At a meeting in September 1959, CORNELL gave his Soviet case officer an account of what he had learned regarding emigré organizations.

...After a 1960 trip to Germany, Belgium, and France, CORNELL gave his Soviet case officer a list of members of the USA Committee in Munich, which list had been given to him by Viktor LARIONOV...

...That same year CORNELL heard from LARIONOV that the U. S. had reduced economic aid to NTS and that many old hands...had stopped working for lack of funds. CORNELL reported this to his Soviet case officer. Some time later, the Soviet asked CORNELL if NTS man MUZANEX was in Finland; CORNELL said he was not, but that LARIONOV had informed him that MUZANEX, who until recently was NTS chief in Sweden, had left the organization because of conflict with the leadership in Germany...

Early in January 1961 CORNELL met the Soviet who, among other things, asked where LARIONOV is working. In order to obtain all the information requested, CORNELL would have to go to Germany and Belgium, which he promised to do during his 1961 summer vacation. He went in July and obtained answers to the questions from LARIONOV and OREKHOV. CORNELL also provided names of all Americans working for the American Committee in Munich; reported that these Americans manage the radio station "Freedom" there and also administer distribution of funds to various organizations and movements hostile to the USSR. CORNELL says that the names of the U. S. citizens and, indeed, the majority of the information gathered during his trip, came from LARIONOV.
