<p><b>Clandestine Cryptographic:</b> Given only to personnel who will be involved in clandestine cryptographic operations. A cryptographic clearance can be waived, under certain conditions, subject to the approval of the Chief, Communications Security Branch.</p> <p>A. <input type="checkbox"/> <b>SPECIFIC COURSE:</b> (140 hours) gives student an understanding of cryptographic communications systems, procedures and security precautions used for a specific clandestine field operation. Enables student to perform cryptographic duties for the specific operation for which training is furnished.</p> <p>B. <input type="checkbox"/> <b>BASIC COURSE:</b> (100 hours) gives student an understanding of basic cryptographic communications systems, procedures and security precautions used for clandestine field operations. Enables student to follow written instructions for a specific cryptographic clandestine operation.</p>			
<p><b>Clandestine Radio:</b> Given only to personnel who will be involved in clandestine radio operations.</p> <p>A. <input checked="" type="checkbox"/> <b>TRAINING COURSE:</b> (Time required subject to student's ability and background.) Includes Morse Code (slow speeds), minor maintenance of agent radio equipment, basic radio theory, and communications procedures. Enables student to establish radio communications as required for his assignment.</p> <p>B. <input type="checkbox"/> <b>BRIEFING COURSE:</b> Familiarizes student with communications security problems, radio equipment and procedures.</p>
