SUBJECT : Ops Discussions

- [] [] a) Stated that Goforth is going to be in DC on 19 & 20 June 58 and inquired if [] would like to see him. [] does not know why Goforth is coming to DC-possibly to discuss the Baltic Institute. ([] indicated by phone on 20 June 1958 that Goforth has come to DC to discuss with Speake the assignment of Mr. Marsens to Argentina as the Latvian Diplomat)
- b) [] Stated that [] son Peter will be naturalized end of June 1958, and that probably it will take a couple of weeks after that to get the Naturalization papers, therefore it will be second part of July before [] family will be able to move to the East Coast and subsequently to Spain. [] was instructed to tell [] family to get 5 passport pictures each and to get their vaccination finished, prior to their departure for DC. [] was also instructed to check info on schedules and boats leaving for Spain and Portugal plus costs of tickets.
- c) Inquired if [] could not be put in touch with our man in (Staff PP Case Officer) who could probably help or give hints where [] could send his kids to school etc. [] was informed that although we might sympathize with [], we could not ask anybody to help out with personal problems for this contact will be used for emergencies only

Churgin: (After [] had left for Bank) Inquired if we have heard that one Ilmars Karklins, who lives in Sweden might be going to Latvia to visit his former wife and relatives. [] promised to check (and called Ch. later that we have not) [] agreed that if we don't know about it Ch. could write to him and inquire among other things if thats true. Ch. knows I.K. personally since some time ago. Churgin also indicated that he read in 31 May 1958 LATVIJA that Boris wife had died. [] acknowledged this. Ch. wanted to know under what circumstances since the paper indicated that she died in Kaufbeuren Hospital which was known to him as insane assylum. [] indicated that we have info which states she died from alcoholism or malnutrition and that we are still checking on this since the case is not quite clear. However she was getting her salary up till the end, and that we are working on her case and that everything is being done to settle Boris estate. Ch. inquired if Petersons and Lukins in Sweden should not be warned about AECOB/7 since they consider him a Latvian patriot and still correspond with him. [] to check with [] in re to this
