*CHURGIN CHANGED HIS MIND AND DECIDED NOT TO TAKE JACOBIN*

- [ ] a) Gave Ch. one Remington typewriter ribbon *FROM 25-29 AUGUST 58*  
b) Checked on Ch. work on the Riga telephone directory, which is almost completed. Churgin was instructed to make and to put in our card file all the bio info he has on the Subjects that are listed in the Directory, and put in the Street Listing cards the ~~ix~~ our card file No's, so that by checking the Street listing we can also find bio info on the persons living at these places, by checking our Name Files. Due to the fact that some of the streets in Riga's Jurmala ( Seashore ) have the same name as the streets in Riga, they will be filed in a separate box as those streets listed in Riga. There are apr. 15,000 addressee

in the Riga Telephone Directory which have been coded in numerical order.  
Churgin: a) Inquired about his status, and was told that the plans have not been changed and that at this time only thing he can do is to be patient. He also informed that his wife has a job offer in Lancaster, Pa, to work as a partner or assistant to a well est. dentist in the locale. She might get this job in Sept. 58.

- b) Inquired if he should do any checking in re to AECOB/7 activities through some of his sources. [ ] informed that a study of A/7 is being made by our office on this subject, and that for time being [ ] did not see any special reason why Ch. should do anything, however [ ] was to check on this with [ ]  
[ ] In reply to Ch. question he was told that we have not received any messages lately from A/7 nor A/10. [ ] also informed Ch. that the former is not directly involved in A/7 and A/10 ops, and therefor has to check prior to giving any satisfactory reply to Ch. questions. [ ] indicated he did not know on when or if Churgin will be given a chance to discuss AECOB/7 case with a CE expert, as [ ] had mentioned to Churgin. In conclusion [ ] indicated that probably by end of this year the final decision will be made and the case study will be concluded ( in re to A/7 ).  
c) Churgin gave [ ] the Videnieks " Applications for Permit to Reenter the USA " which were mailed by them to the Tacoma P&O Box.  
d) [ ] to give Ch. a Riga City plan, in order for Ch. to double check on some of the Riga street names. [ ] inquired about Churgin's
