	<p>1. We have begun to process AECAMBARO/1 for a PCS assignment to Frankfurt, Germany, on the basis of a Covert Security Approval granted Subject on 27 August 1958. In accordance with the reference, the CSA permits the utilization of the Subject for the following duties:</p> <ul style="list-style-type: none"> a. To interview escapees from the Latvian SSR. b. To process letters intercepted from and to the Latvian SSR. c. To process and mail propoganda materials to Latvian SSR. d. To spot for REDSKIN potentials among maritime personnel and in leads obtained through mail intercepts. <p>2. You are to place restrictions on AECAMBARO/1 while he is on PGS in Germany as follows:</p> <ul style="list-style-type: none"> a. He will not have access to any KUBARK installations. b. His contact with Staff personnel will be limited to the extent absolutely necessary for the performance of his duties. c. His contacts with emigre sources, RIS targets, and his overall duties will be closely controlled and supervised. <p>If you wish to use him in any way other than outlined in paragraph 1 above, an amendment to Subject's CSA and Headquarters approval will be required.</p> <p>3. Subject's family has decided to remain in PPRIME for the present, and since the Subject's family separation is not at the convenience of ODYOKE, AECAMBARO/1 is not entitled to a family separation allowance.</p> <p>4. Due to the fact that AECAMBARO/1 will be involved in various activities aside from AEMARSH while on PGS in Germany, we request that you write a Field Project Outline to support his activities.
