(At Baltimore, Maryland)

On 3 February 1960 the Baltimore City Police Department and Maryland State Police Headquarters were contacted in regard to possible record or information regarding a Walther, 7.65 mm. pistol. Their records were completely negative as to any record on the above weapon.

(At Washington, D. C.)

On 4 February 1960 the Federal Bureau of Investigation and the Washington Police Department were contacted with negative results regarding the aforementioned weapon.

On 8 February 1960 the Alcohol Tax Division, U. S. Treasury Department, Internal Revenue Service, was contacted as to any possible information or record on the aforementioned weapon with complete negative results.
