 - A. COMMERCIALIZATION TO BE DISCONTINUED. TIMING TO BE WORKED OUT AS PART NEGOTIATIONS WITH CAWASH.
 - B. ACTIVITIES TO BE DIRECTED SOLELY AGAINST SOVZONE IN LINE ATTACHMENT C EGBA 52531 AS MODIFIED BY COS.
 - C. STAFF REDUCTION TO ABSOLUTE MINIMUM NECESSARY AFTER REORIENTATION.
 - D. FY 60 BUDGET PROGRAMMED FOR DOLLARS
 - E. OBJECTIVE NEGOTIATIONS WITH CAWASH IS MAKE PROJECT JOINT EFFORT, I.E. CAWASH BACKSTOPS LCCASOCK AND MAKES FINANCIAL CONTRIBUTION. IN LINE POSITION DTLINEN IF CAWASH REFUSES BACKSTOP LCCASOCK QUESTION ARISES WHETHER PROJECT SHOULD BE CONTINUED AT ALL.
