WITH FRAN CONCURRENCE SUGGEST YOU INFORM UPSWING:

A. SUBJECT REF IS PRINCIPAL AGENT (LCCASSOCK 1) BOB CADORY PROJECT LCCASSOCK (IDEN) WHICH ONE OF KUBARK REVEALED PROJECTS PREVIOUSLY EXTENSIVELY DISCUSSED WITH VARIOUS UPGROWTH AGENCIES INCLUDING UPSWING. LCCASSOCK HAS BEEN ENGAGED SINCE 1949 IN KUBARK SPONSORED PROPAGANDA OPERATIONS DIRECTED PRIMARILY AGAINST GDR. FOR PAST YEAR PROJECT HAS PUBLISHED JAZZ MAGAZINE "SCHLAGZEUG" FOR COMMERCIAL COVER REASONS WHICH SOLD FEDREP AND DISTRIBUTED IN MINOR QUANTITIES IN GDR.

B. AS RESULT REALIGNMENT OVERALL KUBARK CADORY OPS GERMANY LCCASSOCK WILL BE TERMINATED 31 DEC 1959 AND GO INTO OFFICIAL LIQUIDATION APPROXIMATELY 1 FEB 1960. ALL PROJECT PRODUCTION ACTIVITY WILL CEASE 31 DEC 1959.

C. IN VIEW TERMINATION LCCASSOCK PROJECT, LCCASSOCK 1 CANVASSING VARIOUS PRIVATE AND OFFICIAL GERMAN OFFICES IN HIS OWN INTEREST. SUGGEST UPSWING CONTACT WHO FULLY INFORMED CURRENT STATUS LCCASSOCK PROJECT AND LCCASSOCK 1.

D. SEE NO OBJECTIONS LCCASSOCK 1 UPSWING CONTACT FROM KUBARK VIEWPOINT.
