1. LEON POHL, SURETE LIAISON OFFICER TO BFV, OFFERED FOLLOWING  
BRIEF EXPLANATION RE FRENCH PARTICIPATION IN ALLEGED PARTISAN ACTIVITY:

EARLY 51 COLONEL MUELLER OF SDECE CONCEIVED IDEA OF  
RESISTANCE MOVEMENT IN WEST GERMANY AND FOUNDED "GESELLSCHAFT ZUM  
STUDIUM SOZIALER BEZIEHUNGEN" (GSSB) WITH HQ AT REQUISITIONED  
RHEINHOTEL IN REMAGEN. TOWARDS END 51 FRENCH ABANDONED PARTISAN IDEA  
DUE MAINLY TO RECRUITING DIFFICULTIES AND UNCONTROLLABILITY OF MEN  
ALREADY RECRUITED. HOWEVER, GSSB STILL IN EXISTENCE OSTENSIBLY TO  
FOSTER GOOD RELATIONS WITH GERMAN YOUTH UNDER ALLEGED NATO AUSPICES.  
AT FRENCH REQUEST BFV TRIED UNSUCCESSFULLY TO HAVE STORY WITHDRAWN,  
BUT WIEHE (AUTHOR) HAVING SPENT DM 15,000 ON MATERIAL, "REVUE" DECIDED  
PUBLISH IT.

BY BRAUNSCHWEIG CRIMINAL POLICE PRODUCED MOST CONTRADICTIONARY STATEMENTS WHICH ABSTRACTED IN PARA 3 BELOW. FOLLOWING PERSONS MENTIONED IN ANDERS' INTERROGATIONS:

(A) WILHELM DORTANTS ALIAS BILT, BORN 1926, ORIGINALLY DUTCH CITIZEN BUT BECAME GERMAN ON UNKNOWN DATE. ADDRESS: BRAUNSCHWEIG, HILDESHEIMERSTR. 70. FORMER MEMBER OF WAFFEN-SS, WANTED BY DUTCH FOR WAR CRIMES.

(B) GUIDO BAYER, DRUGGIST NOW CHEMIST IN MARBURG. HAS THREE ADDRESSES: MARBURG/LAHN, MARBACHERSTR. 47; BONN, AARGELANDERSTR. 85 BEI SCHWARZENBERG; REMAGEN, RHEINHOTEL. MEMBER OF FREIE UNION AND FDGB.

(C) HEINZ ANDERS ALIAS SCHAUT, BORN 16 AUGUST 16 IN FRANKFURT/ODER. FORMERLY LIVED IN BRAUNSCHWEIG, SCHARNHORSTSTR. 10 (WHERE HIS FAMILY STILL RESIDES), MOVED TO WIESBADEN SOMETIME IN 51. 1933 MEMBER OF HITLERJUGEND. 1933 - 34 ALLGEMEINE SS AND REICHSARBEITDIENST. 1934 - 45 WAFFEN-SS. 1945 - 47 ALLEGEDLY AGENT OF AIS AND BIS TO ESTABLISH SOVZONE CONTACTS. 1947 - 49 SENTENCED (UNKNOWN BY WHOM) FOR ALLEGED FRAUD, ECONOMIC CRIMES AND ILLEGAL POSSESSION OF ARMS. MARCH 50 APPLIED FOR MEMBERSHIP IN "KAMPFGRUPPE GEGEN UNMENSCHLICHKEIT" IN GOETTINGEN BUT WAS REFUSED.

(D) URSULA WILKE, ABOUT 23 YEARS OLD, SUSPECTED WORKING FOR FIS.

(E) ARNOLD SCHMIDT-TRAPPENBERG, HEAD OF GSSB AT RHEINHOTEL; REMAGEN.

(F) GLAHN NOT MENTIONED IN ANDERS INTERROGATIONS.

3. ESSENTIAL POINTS EXTRA<sup>CTED</sup> ~~(PORTION COULD BEING SVCD)~~ FROM ANDERS' INTERROGATIONS ON FOLLOWING DATES:

(A) 18 MARCH 51: ANDERS CLAIMS TO HAVE BEEN RECRUITED BY BAYER ON RECOMMENDATION OF DORTANTS. BAYER SUPPOSEDLY HAD ANDERS CLEARED BY RADKE AND GALEN OF BFV, LENZ, AMT BLANK, GEHLEN. UPON RECEIPT THIS STATEMENT BY ANDERS, BFV CALLED IN BAYER WHO DENIED EVERYTHING.

[ ] COMMENT: IS THIS ANDERS IDENTICAL WITH FORMER AGENT OF SAME NAME IN CAPOTE CHAIN?)

(B) 15 JUNE 51: WILKE SUPPOSEDLY TOLD ANDERS THAT HE WOULD SOON MEET PETERS AND BE APPOINTED INSTRUCTOR AT BDJ SCHOOL AT LAUFACH, BUT PETERS NEVER APPEARED. AFTER COMPLETING COURSE ANDERS TO BE INTEGRATED IN EUROPEAN PARTISAN CONTINGENT.

(C) 10 DEC 51: UNNAMED FRENCH OFFICER TOLD ANDERS TO ATTEND FOUR WEEKS' COURSE IN BADEN-BADEN ON 1 FEB 52 FOLLOWED BY FOUR WEEKS' COURSE AT PARTISAN SCHOOL IN FRANCE ON 1 MAR 52. UPON RETURN ANDERS

TO TAKE CHARGE ALL PARTISAN ACTIVITIES WEST GERMANY WITH HQ AT WIESBADEN. ANDERS CLAIMS TO HAVE CALLED ON RADKE AND STRAUSS OF BFV WHICH RADKE SAYS IS PURE INVENTION AS HE HAS NEVER MET HIM. ANDERS CLAIMS TO HAVE BEEN IN INNSBRUCK AND PARIS TO CONTACT FRENCH STAFF OFFICERS.

(D) 9 DEC 52: ANDERS SAYS SCHMIDT-TRACZENBERG'S "GESSELSCHAFT" IN REMAGEN CONTROLLED BY COL. MUELLER WHO HAS HIS HQ IN VILLA NEXT TO PENSION HOEHENBLICK IN BADEN-BADEN. AT MUELLER'S REQUEST ANDERS CLAIMS TO HAVE MADE TWO TRIPS TO INNSBRUCK TO ORGANIZE TYROLEAN PARTISAN MOVEMENT TO BE TURNED OVER TO JAKOB HAMEICH IN BAD HALL. FROM 1 TO 12 APRIL 52 ANDERS CLAIMS TO HAVE ATTENDED COURSES FOR HANDLING EXPLOSIVES AT BADEN-BADEN AND RASTATT. FRENCH AUTHORITIES ALLEGEDLY PAID HIM SALARY OF DM 600 AND EXPENSES OF DM 400 - 500 MONTHLY.

(E) 23 JAN 53: ANDERS CLAIMS TO HAVE WORKED FOR BIS AND AIS FOR SOME MONTHS. HIS REPORTS WERE SENT TO STUTTGART WHERE HE VISITED ABOUT TWICE A MONTH. STUTTGART EVENTUALLY DROPPED HIM FOR UNRELIABILITY. HE ALSO CLAIMS TO HAVE MADE UNSUCCESSFUL RECRUITING ATTEMPTS OF FORMER SS-MEN IN BELGIUM. MUELLER ALLEGEDLY REPRESENTED HIMSELF AS BEING UNDER NATO AND WISHED TO TURN PARTISAN ORGANIZATION OVER TO GERMAN CONTROL. ANDERS CLAIMS TO HAVE RECEIVED DM 900 FOR MARCH 53 FROM
