PROJECT OUTLINE

CRYPTONEM - CADUCITY

1 July 1951 - 30 September 1952

PART I

1. **Area of Operations:** Berlin, Germany.
2. **References:** The operational lead was provided by CAUTERY 3 and exploited in cooperation with CAISSON 19 and CAUTERY 2. These three now have no further connection with the CADUCITY operation.
3. **Purpose:**
 - a) **Objectives:** Economic data, especially labor statistics. Personality and organizational information on the Staatliche Planungs Kommission (State Planning Commission) of the East German Government.
 - b) **Targets:** State Planning Commission, Ministries of Heavy Industry, Light Industry and Machine Construction. Specific factories except SAG's.
 - c) **Tasks:** To gather data listed under a) and to provide personality leads for recruitment purposes which come to agent by virtue of his official position.
4. **Personnel:** CADUCITY is a 37-year-old German currently holding the position of chief of the Production Planning Section of the State Planning Commission, responsible for the highest governmental level of economic planning. The main job of CADUCITY's section is to determine the production capacity of all industrial units in the Soviet Zone of Germany. The section works in close conjunction with the Ministries of Heavy Industry, of Light Industry, and of Heavy Machinery.
5. **Cover:** Case officer represents U.S. intelligence. Agent's cover for obtaining intelligence data is his actual job.
6. **Contact and Communications:** Agent calls on the special agent phone. Date of meetings and place of pick-up pre-arranged at previous meeting. Meetings are held at a safe house. No sub-agents involved. No special problem of communications.
7. **Control:** Partly ideological, but largely financial, for agent feels he is insuring his financial security if he should be forced to flee to Western Germany. He also wishes to attain personal security through help in reaching the West Zone, if necessary. Agent has signed receipts for money received. His compensation is being deposited and held until the termination of his intelligence work for us.

9. Coordination: None.
10. Timetable: Operations started on 1 January 1951. No foreseeable date of termination.

11. Estimated Cost for period from 1 July 1951 to 30 September 1952:

12. Special Problems and Commitments: Disposal commitments, including agent's wife and child, comprise provision of secure travel to the West, procurement of residential permit and a testimonial of service.
