2. SUBJECT WAS THE OBJECT OF AN EXTRADITION REQUEST INITIATED BY THE USSR MINISTRY OF FOREIGN AFFAIRS ON 11 OCTOBER 1961. OFFICIAL SOVIET PRESS AND RADIO REPORTS ACCUSED SUBJECT OF ATROCITIES DURING THE NAZI GERMAN OCCUPATION OF ESTONIA.

3. INVESTIGATIONS CONDUCTED BY BOTH THE SOVIET GOVERNMENT AND VARIOUS JEWISH ORGANIZATIONS REVEALED THAT SUBJECT SERVED AS DUTY OFFICER IN A CONCENTRATION CAMP IN TARTU, ESTONIA FROM JULY TO AUGUST 1941. FROM AUGUST 1941 TO MAY 1942 SUBJECT WAS CHIEF OF THE CAMP. HE WAS ACCUSED OF BEING RESPONSIBLE FOR MASS EXTERMINATIONS AND OTHER ATROCITIES COMMITTED AGAINST THE INMATES OF THE CAMP.
