WHOM SUBJ "BETTER NOT REBUFF". AS MUCH AS STATED SUBJ WOULD HAVE TO PERFORM SMALL MISSIONS (FAVORS) IF DOES NOT RETURN.

B. DURING CONVERSATION WITH COURIER SUBJ WENT TO ROOM PROF FNU REICHARDT AND WIFE (OWNERS APARTMENT IN WHICH SUBJ LIVES) STATING HUNGARIAN AGENT IN HIS ROOM ATTEMPTING PERSUADE HIM RETURN.
