1. SUBJ LREF MET BY [] JAN. REVIEW DETAILS APPROACH BROUGHT SUBSTANTIALLY SAME STORY REPORTED REF. HOWEVER SUBJ BELIEVES HE MADE CLEAR HE WOULD NOT COOPERATE WHEN ROSE INTIMATED SUBJ WOULD HAVE TO PERFORM MISSIONS IF SUBJ STAYED WEST. SUBJ SOMEWHAT DOUBTFUL HE WILL BE RECONTACTED.

2. SUBJ SEEMS INTELLIGENT FULLY COOPERATIVE. WANTS RETURN HUNG UNDER NO CONDITIONS. TAKES REALISTIC ATTITUDE RE FAMILY WHICH HE HAS NO HOPES EVER SEEING AGAIN. BELIEVES FATE FAMILY WILL BE DECIDED COMPLETELY APART FROM WHAT HE MAY DO BUT WANTS PROTECT THEM EXTENT POSSIBLE. FEARS ATTEMPT ABDUCT HIM IN ORDER CAPITALIZE PROPAGANDA HIS RETURN. BECAUSE OF AGE SEES NO SENSE EMIGRATING AND INTENDS REMAIN GERMANY. WILLING PUT SELF COMPLETELY UNDER OUR DIRECTION WHICH REAFFIRMED AFTER DEMANDS WHICH MIGHT BE PUT ON HIM WERE OUTLINED.

3. STORY SUBJ'S APPROACH HAS APPARENTLY NOT LEAKED. SUBJ GAVE ROSE APPARENTLY ADEQUATE COVER STORY FOR LEAVING ROOM DURING CONVERSATION (TO INFORM REICHARDTS OF VISIT). PENDING RESULTS FURTHER DEBRIEFING SUBJ, SUBJ AND CIRCUMSTANCES APPEAR SUITABLE FOR DA PLAY IF SUCH DEVELOPS. [] STATES SUBJ HAS NO ACCESS
