1. In accordance with the terms of the BECRIPPLE project the individual named has been engaged by me, under oral contract, for an indefinite term. The effective date of oral contract is 1 October 1956.

2. Until further notice Subject will receive a monthly salary of 550.00 DM West. Subject will be reimbursed for all operational expenses incurred. Subject will receive per diem while on operational travel, the amount not to exceed 25.00 DM West for any one day period.

3. In accordance with oral contract Subject is not entitled to annual or sick leave benefits, disability compensation, nor will his dependents be entitled to death benefits.

4. Subject is authorized a yearly Christmas bonus not to exceed that allowed by existing German Mission regulations.
