Expulsions from the Committee of Anti-Fascist and Progressive Ethnic Germans (KOMITEE ANTIFASCHISTISCHER UND FORTSCHRITTLICHER VOLKSDEUTSCHER)

21 April 51

The following information was submitted by Informant 1609. Evaluation: Source "C" (fairly reliable); information: "3" (possibly true).

An item in the 21 April 1951 issue of "Der Kleine Landwirt", a Communist publication, stated that Peter KROMER, Maria KROMER, and Paul KROMER, residing in Ohlsdorf, Upper Austria, have been expelled from SUBJECT Committee because of "active co-operation with the military organization of the Fascist-Hungarian Emigrés".

AGENT'S NOTE: It is believed that the organization referred to in this report as "the military organization of the Fascist-Hungarian Emigrés" is actually the MHBK (Magyar Harcosok Bajtarsi Koezessege - Hungarian Warriors' Comradeship Association), an intelligence organization headed by General Andreas ZAKO, former chief of Hungarian Intelligence during World War II. This organization claims 500 members in the Salzburg area under the local direction of General János BURGET, a former Hungarian officer.

FILE CHECK: The background and current activities of the MHBK are described in MOIC-S-8192, Subject: "Comradeship of Hungarian Warriors (ZAKO group)", dated 15 August 1950.

The Committee of Anti-Fascist and Progressive Ethnic Germans is mentioned numerous times in the files of this Sub-Detachment as a Communist-controlled organization.

SOI-L-18975, Subject: "Austria-Membership List of Anti-Fascist Volksdeutsch, Upper Austria", dated 16 May 1950, lists Maria KROMER, born 13 October 1885, Paul KROMER, born 29 June 1917, Peter KROMER, born 10 May 1880, all residing at Ohlsdorf, Aichham 11, as members of SUBJECT organization.
