On 14 June 1954, Informants 5019 and 5020 were interviewed and stated in substance that recent events, where in Sander Hajnadi was jailed for an alleged assault upon a Czechoslovakian Displaced Person, have made it all too apparent that increased police pressure is being applied to the MHBK (Magyar Harcosok Bajtarsi Kozossege - Hungarian Warriors Comradeship Society) and its members.

Approximately six (6) weeks ago, Hajnadi was discharged from employment with the American Forces in Austria and it was believed by Hajnadi that this was a result of a false report given to the Austrian police that Hajnadi had carried a red flag in a Communist parade in the town of Urfahr/Linz, (Soviet Zone) Upper Austria. Hajnadi was alleged to have sought revenge by attacking the police informant, one Josef Blaskovic, in a public bus. Hajnadi was then arrested, detained for approximately four (4) weeks and then cleared of the charge. Nevertheless, Dr. Josef Koller of the Linz, Austria, Police Directorate utilized this time for repeated interrogation of Hajnadi to gain information regarding other members of the MHBK and the purpose of the organization. Koller was said to have accused the MHBK of subversive activities. In regard to Hajnadi personally, the fact that he was discharged from his job with the Americans is tantamount to proof that he is engaged in subversion. Hajnadi was told that he is to be expelled from Austria.

According to Sources, the MHBK is forbidden to hold any further meetings in the Linz Area. In a recent meeting between Dr. Keller and Informant 5019, when the latter sought permission to hold an MHBK meeting he was refused. It was explained by Sources that only recognized political parties are permitted to hold meetings and, although the MHBK was previously allowed to assemble, it is not recognized as a political party by the Austrian government. The permission granted for previous meetings did not constitute recognition by the national government; rather, it came from the apparent willingness of the police to cooperate with the MHBK. Recently it was learned that a Russian official in Vienna, Austria, has complained to Austrian officials concerning the implied permission granted to the MHBK, and demanded that it be stopped. It is therefore assumed that regardless of the suspicions of the Linz Political Police Section concerning the MHBK, pressure is being placed on the local officials to bring about a cessation of the functions of

the Linz Area unit of this organization. Thus far, it appears as though all other units will continue to hold meetings.

The Hungarians living in this area are indeed worried. Citing the case of Hajnadi and his imminent removal from the country, it is believed that a trend might be established whereby the mere allegation of wrong-doing lodged against a displaced persons is sufficient to assume him to be guilty and cause his expulsion from the country. It is suspected that Br. Keller has at least five (5) informants among the Hungarians, who live at Camp Wegscheid, all of whom are actively working against the MHBK and its members. (C-3)

On 16 June 1954, the name files of the Regional Registry, 430th CIC Detachment, Region "B", APO 174, US Army, were examined concerning the following persons named in this report and the following information was revealed:

~~Senior Alexander Hajnadi:~~ Numerous reports were found wherein it was variously recorded that Hajnadi, born 19 February 1922, ~~Suzsag, Hungary~~, fled to Austria in October 1948. He assumed residence at Camp Wegscheid, Land Upper Austria, and became secretary of the MHBK. He was employed in the dependent housing area as a fireman, and was accused by one Source as being a Communist agent and member of the Communist Party who promotes disunity among the Hungarian element in camp.

Agent's Note: Information regarding Hajnadi is evaluated as B-2, except for that portion denouncing him as having anything to do with the Communist Party, which is evaluated as F-6.

Josef Blaskovic: L/27504, dated 2 October 1953, Subject: "Langner, Viktor, Alleged Employee of Western Intelligence Agency, Upper Austria, Linz", denounces Blaskovic as a secret service spy in Czechoslovakia during the Bela Kun era and, currently, a reporter of untrue stories to Linz CIC. He is accused of preventing the emigration of many refugees and hindering the cause of free Slovaks. (no evaluation)

Numerous reports were found wherein Blaskovic was the Source.
