1. RE YR 206. FOLLOWING IS ITINERARY FILIPPA: RIO, 20 MARCH. SUGGEST CONTACT WITH JK 44 AT BA WHERE HE CAN BE REACHED C/O UNITED SHIPPING AGENCY LTD., RECCOQUISTA 336. IS USING REAL NAME.
 2. FOLLOWING PASSWORD MAY BE USED BY CUT-OUT: "PORTO SALUTI DA FRANCO CHE NON PUO ASPETTARE PER LA SUA TELEFONATA A GENOA, SPERA CHE LE BANANE NON MARCISCONO QUESTA VOLTA E CHE SALTROVERANNO ANCORA DEI ANANAS." ("I BRING GREETINGS FROM FRANK WHO CANNOT WAIT FOR YOUR TELEPHONE CALL AT GENOA; HE HOPES THAT THE BANANAS WILL NOT ROT THIS TIME AND THAT THERE WILL BE SOME PINEAPPLES AGAIN.") CAN BE GIVEN IN ITALIAN SPANISH OR FRENCH, FIRST PREFERABLE.
 3. WE DESIRE THAT JK 44 THEN BE PASSED FOLLOWING QUESTIONS, DETAILED ANSWERS TO WHICH DESIREABLE BE PASSED DIRECTLY TO CUT-OUT AT SUBSEQUENT APPOINTMENT FOR LOCAL FOLLOW-UP AND ONWARD TRANSMISSION SOONEST TO YOU:
 - A. DESCRIPTION OF ALL SUSPICIOUS RELATIONSHIPS MANIFESTED AMONG FILIPPA PASSENGERS.
 - B. DETAILED ACCOUNT OF REACTION AMONG JUGS ON BOAT AFTER ARREST AND DETAINMENT 16 SUSPECT PASSENGERS AT GENOA.
 - C. FURTHER INFO ON INDIVIDUAL NOW IN BA WHO FORMERLY WORKED IN GENOA UNDER PCI CONTROL TAPPING THE MILITARY TELEPHONE LINE. NAMES PAST AND PRESENT COLLEAGUES THIS PERSON STILL IN ITALY. WHAT DONE WITH INFO INTERCEPTED. WHO WAS CHIEF AND OTHER CONTACTS IN OPERATION? WHY AND HOW DID HE LEAVE ITALY? WHERE WAS TAPPING STATION LOCATED, ETC.?
